

# Hoke County Water System

## Water User's Agreement

This agreement entered into between Hoke County, a body politic and corporate, hereinafter called the "County" and \_\_\_\_\_ hereinafter called the "Customer".

Witnesseth:

Whereas, the Customer desires to purchase water from the County and enter into a Water User's Agreement as required by the Rules and Regulations of the Hoke County Water System.

Now, therefore, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed by the parties hereto as follows:

The county shall furnish, subject to the limitations set out in its Rules and Regulations now in force or as hereafter amended such quantity of water as Customer may desire in connection with Customer's occupancy of the following described property:

The Customer agrees to grant the County, its successors and assigns, a perpetual easement in, over, under and upon the above described land, with the right to erect, construct, install and lay and thereafter use, operate, inspect, repair, maintain, replace and remove water pipelines and appurtenant facilities, together with the right to utilize adjoining lands belonging to the Customer for the purposes of ingress to and egress from the above-described lands;

The Customer shall install and maintain at the Customer's expense a service line which shall begin at the meter and extend to the dwelling or place of use. The service line shall connect with the distribution system of the County at the nearest place of desired use by the Customer, provided the County has determined in advance that the system has sufficient capacity to permit delivery of water at that point;

The Customer agrees to comply with and be bound by the Rules and Regulations of the County, now in force, or as hereafter duly and legally supplemented, amended or changed.

The Customer acknowledges receipt of a copy of the current Rules and Regulations of the Hoke County Water System by the Hoke County Board of Commissioners, which Rules and Regulations are incorporated herein by reference, and made part of this agreement as fully as if set out herein.
